#### Description of Product

### **MAXIFLO™ Resilient Seated Gate Valve for Drinking water, Non drinking water and Sewerage pressure pipeline systems.**

- DN80 – DN300 (Flange – Flange) end configurations only.
- Anti clockwise closing direction for water valves, Clockwise closing direction for sewerage valves.
- Blue coated valve spindle cap - drinking water, Purple coated spindle cap – non drinking water

**Conditions:**

1. This Authorisation consent applies only to those items listed in this Certificate and Melbourne Retail Water Agencies (MRWA) web portal for Drinking water, Non drinking water and sewerage pressure pipeline systems.

3. The items described above are authorised for use in South East Water's infrastructure systems, in accordance with the design and installation practices as detailed or referenced in the MRWA Edition of the Water Services Association of Australia Water Supply Code of Australia WSA 03:2012, Pressure Sewerage Code of Australia WSA 07-2007, Sewerage Pumping station Code of Australia WSA 04-2005, MRWA Supplements, South East Water technical Addendums and installation recommendations provided by the manufacturer.
4. This Authorisation consent is valid for 36 months from the issue date of this certificate. Renewals of approval should be sought 3 months prior to approval expiry.
5. AAP Industries Pty Ltd shall be responsible for assuring the quality of approved products that are supplied to the industry market. Where approved products or parts thereof are manufactured or assembled by a third party, AAP Industries Pty Ltd shall employ systematic procedures to verify product conformance.
6. The product shall be either manufactured or supplied under a third party certified ISO 9001 Quality Assurance Management System. All products shall be identified with the manufacturers name or trademark.
7. The products shall demonstrate satisfactory performance when installed on any infrastructure system in South East Water's licensed district.
8. South East Water shall be notified in writing if:

  - The products are to be withdrawn from sale.
