Conditions of Authorisation:

2. This Authorisation does not refer to the effectiveness of the product and no claim shall be made through advertising, promotion or in any other way that the above products have been authorised or tested by Yarra Valley Water in other than the terms of this authorisation.
3. The items described above are authorised for use in Yarra Valley Water infrastructure systems, in accordance with the design and installation practices as detailed or referenced in the MRWA Editions of the Water Services Association of Australia Codes, Yarra Valley Water's supplement to the code and other recommendations of the manufacturer.
4. Provisional approval is valid for 12 months minimum. Full approval shall be granted following completion of a successful provisional period and for 5 years. Renewals of approval should be sought three months prior to approval expiry.
5. **AAP Industries** shall be responsible for assuring the quality of approved products that are supplied by **AAP Industries** to the market. Where the approved products or parts thereof are manufactured or assembled by a third party, **AAP Industries** shall employ systematic procedures to verify product conformance.
6. The product shall be manufactured under a third party certified Quality Assurance System. All products shall be identified with the manufacturers' name or trade mark.
7. The products shall demonstrate satisfactory performance when installed in Yarra Valley Water's Infrastructure system.
8. Yarra Valley Water shall be notified in writing if:
 - the third party certification is withdrawn, suspended or changed;
 - any change of the certification agency occurs;
 - there are any changes to product design, materials, model numbers, etc, or
 - the products are to be withdrawn from sale

9. The products may be subjected to random quality control checks for which a charge may apply. Compliance with new Standards as they are replaced will need to be demonstrated.
10. Yarra Valley Water reserves the right to request additional information and/or evidence of product suitability, add or vary the conditions set out above, or if necessary, modify or withdraw the authorisation at any time.
